



Terms, Conditions and Hire agreement

Please read these terms and conditions before using Hire A Gym services

1. The minimum hire period is 6 weeks.
2. Hire fees are made for each week thereafter.
3. Hire A Gym require seven days notice to terminate the hire.
4. The hire charge will start from day of delivery to Day of collection (unless there is a delay due to Hire A Gym)
5. A full week's hire fee will apply to part week hire.
6. During the hire period any overdue payments will result in interest being charged at 2% above the current Bank of England base rate with an admin fee of £25 per missed payment.
7. Delivery fess will be agreed and will be payable on delivery. The day's and times are given in good faith.
8. Hire A Gym equipment cannot be removed from the property it was delivered to.
9. Upon delivery 6 weeks hire fee is required and arrangements for any other hire after that period e.g. standing/orders mandate or cheque (supported by a guarantee card).
10. On the day of Delivery we also require 2 proofs of identity e.g. Passport/drivers licence, proof of residence e.g. gas or electricity bill/water rates/council tax, however no mobile bills.
11. Hire A Gym staff are not trained fitness instructors so can only instruct you on how to operate the machines.
12. If at the end of your hire period you wish to purchase the equipment we will be open to offers but do not have to sell if we think the offer is not enough.
13. Please note Hire A Gym will not accept goods returned in non-original packaging.
14. On delivery the Hirer must agree and uphold these terms and conditions and take responsibility for the care and condition of the item they are in possession of.
15. The hirer must pay any cost for repair or replacement caused by misuse of equipment.
16. The hirer must ensure that the equipment is in good working order upon delivery.
17. The equipment must be returned with no damage or modifications at the end of the hire period and in good working order.
18. The hirer is responsible for day to day care and maintenance of any item they have from Hire A Gym.
19. Hire A Gym will not release any personal details to third parties.
20. Any faults or defects must be reported to Hire A Gym as soon as found.
21. The weight restrictions on the equipment must be adhered to foe the whole time of hire (restrictions can be found on our website)
22. Hire A Gym do not make gym equipment and cannot accept responsibility for injuries or accidents caused by its use.

23. Hire A Gym can and will terminate the rental contract if it thinks you are in breach of contract or on default payments.
24. It is the hirer's responsibility to make sure it's equipment is insured under a fully comprehensive policy for the hire period.
25. The hirer must not let anyone under the age of 16 use any of the equipment.
26. Hire A Gym recommend that you consult a doctor before you start an exercise program.
27. The equipment remains the property of Hire A Gym and the hirer shall not sell or modify or assign it in any way.
28. Any proof of residency must not be more than 3 months old.
